# Introduction to JCEMS

#### Aims and Scope

*JCEMS* will publish the only scholarly, peer-reviewed journal and news source dedicated exclusively to the collegiate EMS community. Our mission is to promote leadership, clinical excellence, and original research. We stand side-by-side with collegiate EMS agencies, campus safety departments, and university health centers to protect the health and safety of the people on our campuses.

In the scholarly research literature and popular sources, the field of collegiate EMS is sadly underrepresented. Less than a handful of studies have been published on collegiate EMS in peer-reviewed journals, and few articles in popular sources have featured collegiate EMS organizations. We strive to provide a voice to the collegiate EMS community and to spur a revolution in collegiate EMS research. In addition to publishing high-quality content from recognized experts, we encourage and mentor budding leaders, clinicians, and researchers –students and young alumni– to develop high-caliber articles and research projects.

We will publish a seasonal print journal and provide open-access content year-round at CollegeEMS.com. We welcome original research manuscripts, case studies, and reviews to undergo a double-blind peer review process. In addition, we welcome pieces featuring news and commentary, expert perspectives and opinions, advice on best practices, and letters to the editor.

# **Become a Reviewer**

#### Qualifications

Potential reviewers are expected to meet the following qualifications, all of which should be listed in a CV or resume:

- Expertise in emergency medical services (EMS) or emergency medicine, *or* expertise in a relevant field (e.g. campus public health, campus public safety, student affairs, education, etc.), *or* expertise in a specific methodological discipline (e.g. statistics, survey design, etc.).
- One or more original research publication. This requirement may be waived provided the applicant demonstrates otherwise outstanding academic and scholarly achievement (e.g. published case reports or review articles, significant conference presentations, advanced academic degrees, editorial experience).

A select number of exceptionally qualified **students and young alumni** may be selected as reviewers to offer a unique and valuable perspective. Although student and young alumni reviewers may not have published work, references and recommendations should attest to the applicant's academic and scholarly merit. Student and young alumni applicants are expected to have outstanding academic achievement, significant leadership experience in collegiate EMS, and strong research experience. Furthermore, student and young alumni applicants are expected to have a continued interest in EMS, emergency medicine, and/or research as evidenced by a description of their projected career path and/or plans for graduate education in their cover letter.

#### **Expectations**

Reviewers are expected to:

- Respond to an invitation to review a *JCEMS* manuscript within 3 days, indicating whether or not the reviewer accepts the invitation.
- Complete assigned reviews within 14 days of the initial invitation. Notify the editors if the review will not be completed within 14 days.
- Thoroughly familiarize themselves with *JCEMS* submission guidelines as detailed in the *JCEMS Guide for Authors*.
- Thoroughly familiarize themselves with ethical guidelines for research and publishing as outlined in the *JCEMS Guide for Authors*.
- Maintain confidentiality during the review process. Reviewers may not share manuscript details or identify themselves as a reviewer during the review process.

#### Benefits

*JCEMS* reviewers enjoy the following benefits:

- An annual letter of gratitude written on official *JCEMS* letterhead for their academic record. The letter will note the number of reviews performed by the reviewer in the preceding year.
- Annual acknowledgment of the most active reviewers in the print version of *JCEMS*, with the permission of the acknowledged reviewers.
- Professional development, establishment of expertise, improvement of scholarly reputation, and contribution to the collegiate EMS community.

#### **Application Process**

Individuals interested in being a reviewer should submit the following items to the Editor-in-Chief at JCEMS@CollegeEMS.com:

- 1. CV/resume
- 2. Cover letter, detailing their interest and qualifications.
- 3. Contact information (email and phone) for three references who can attest to the applicant's qualifications and expertise. *JCEMS* prefers that reference(s) are individual(s) with editorial or review experience.
- 4. *Optional*: Letter(s) of recommendation, preferably from individual(s) with editorial or review experience. It is preferred that letters of recommendation be sent directly from the recommender, not the applicant.

# **Become an Editor**

#### Qualifications

Our Editorial Board is composed of clinicians, researchers, educators, and leaders with extensive records of service in collegiate and public safety EMS. Editorial Board members include experts in EMS, emergency medicine, and related fields. Editorial Board positions are typically offered by invitation only. An individual interested in being on the Editorial Board, who has not been invited, should first apply to become a reviewer.

#### **Expectations**

Editorial Board members are expected to:

- Coordinate with reviewers during the peer review process.
- Review and edit submitted manuscripts that undergo editorial review.
- Advise on journal policy, design, and scope.
- Attract new authors and manuscript submissions.
- Select new reviewers and Editorial Board members.

#### **Benefits**

JCEMS editors enjoy the following benefits:

- Professional development, establishment of expertise, improvement of scholarly reputation, and contribution to the collegiate EMS community.
- Recognition in every *JCEMS* print issue and on our website.

#### **Application Process**

Editorial Board positions are typically offered by invitation only. An individual interested in being on the Editorial Board, who has not been invited, should first apply to become a reviewer.

# **Submission Review Process**

#### **Overview**

Manuscripts classified as *Original Research*, *Case Reports*, or *Reviews* will undergo a double-blind, peer review process. Manuscripts classified as *News and Commentary*, *Perspectives and Opinions*, *Best Practices*, *Product Reviews*, or *Letters to the Editor* and Images, Video, Training Materials, or Agency Documents will undergo editorial review. For more information on manuscript classification, please see the *JCEMS Guide for Authors*. Reviewers are expected to thoroughly familiarize themselves with their roles in the peer review process.

#### **Double-Blind Peer Review**

Manuscripts classified as *Original Research*, *Case Reports*, or *Reviews* will undergo a double-blind, peer review process. *JCEMS* reviews manuscripts in accordance with strict ethical and professional guidelines and employs a double-blind peer review process to ensure that articles are fairly reviewed without bias. Revisions suggested by reviewers may dramatically strengthen the quality of submitted manuscripts. The process also ensures that published articles demonstrate the utmost level of accuracy, reliability, and methodological rigor. Double-blind, peer review is widely regarded as the gold standard of scholarly publication review; the process is widely employed by top-ranking emergency medicine journals including *Annals of Emergency Medicine* and *The American Journal of Emergency Medicine*.

Manuscripts will initially be reviewed by our editors for quality, relevance to the collegiate EMS community, and suitability for *JCEMS*. High-quality manuscripts that fit the scope of our scholarly journal will be assigned to one of our Editorial Board members who will identify at least two independent reviewers. Manuscripts presenting original research will be reviewed by reviewers with expertise in the specific research field and methodology presented. Manuscripts containing clinical or medical information will be reviewed by at least one reviewer or Editorial Board member with an advanced clinical degree (e.g. MD, DO, PA-S, NP) prior to acceptance. Manuscripts may also be reviewed by additional members of our Editorial Board.

Reviewers are expected to respond to an invitation to review a manuscript within 3 days, indicating whether or not the reviewer accepts the invitation. Upon acceptance of the invitation, reviewers are expected to complete assigned reviews within 14 days of the initial invitation. If the reviewer is unable to complete the review with 14 days, it is the responsibility of the reviewer to notify an editor. Reviewers are expected to provide a thorough review of the manuscript for quality, accuracy, scope, methodological rigor, depth of research, originality/novelty, and style/organization. In addition, reviewers will further review manuscripts in terms of their implications for practice for collegiate EMS providers, leaders, advisors, and affiliated personnel. Reviewers must submit the *Manuscript Review Form* (see below) to the Editorial Board.

Reviewers will be double-blinded, meaning that neither the author nor the reviewers will know the identify of each other during the review process. It is the responsibility of the reviewer to refrain from identifying themselves as a reviewer to the public during the review process. Once the review process is complete, reviewers may choose to reveal to the author or the public that they reviewed a specific article. If the reviewer believes that they know the identity of the author, or are otherwise unable to provide an unbiased review, it is the responsibility of the reviewer to contact an editor. After compiling the reviewers' feedback, the Editorial Board will determine whether a manuscript has been accepted or rejected, or whether revisions are necessary. In most cases, prior to acceptance in our scholarly journal, major or minor revisions in the article's content and/or writing will be necessary. Revisions for original research manuscripts may include the need to perform additional data collection and/or analysis. Manuscripts will undergo a second round of peer review after revisions are completed by the author. Prior to publication in our scholarly journal, our editors will provide copy-editing and formatting assistance. Authors will receive a final, edited version of their article prior to publication in our scholarly journal. Final decisions on manuscript publication will be made by the Editor-in-Chief or a member of the Editorial Board without any relevant conflicts of interest.

#### Editorial Review

Manuscripts classified as *News and Commentary*, *Perspectives and Opinions*, *Best Practices*, *Product Reviews*, or *Letters to the Editor* and Images, Video, Training Materials, or Agency Documents will undergo editorial review. Manuscripts will initially be reviewed by our editors for quality, relevance to the collegiate EMS community, and suitability for *JCEMS*. High-quality manuscripts that fit the scope of our scholarly journal will be fully reviewed by members of our Editorial Board. In select cases, independent reviewers with special expertise may be requested.

The Editorial Board will provide a thorough review of the manuscript for quality, accuracy, scope, methodological rigor, depth of research, originality/novelty, and style/organization. Manuscripts will be further reviewed in terms of their implications for practice for collegiate EMS providers, leaders, advisors, and affiliated personnel. Manuscripts containing clinical or medical information will be reviewed by at least one editor with an advanced clinical degree (e.g. MD, DO, PA-S, NP) prior to acceptance.

After the first stage of peer review is complete, authors will be notified whether their article has been accepted or rejected, or whether revisions are necessary. In most cases, prior to acceptance, major or minor revisions in the article's content and/or writing will be necessary. Articles will undergo a second round of editorial review after revisions are completed. Prior to publication, our Editorial Board will provide copy-editing and formatting assistance. Authors will receive a final, edited version of their article prior to publication in our scholarly journal. Final decisions on manuscript publication will be made by the Editor-in-Chief.

#### Manuscript Review Form

Reviewers who accept an invitation to review a manuscript are expected to submit the following form and an attached review within 14 days of receiving the invitation:

Please support your judgment of the manuscript with specific facts and by pointing to specific sections/wording from the article.

All recommended revisions from minor (grammar, writing style, organization structure, minor requests for additional research/background, etc.) to major (major requests for additional research/background) are greatly appreciated.
